### Finance (Dennis):

- Current Financial balance is \$28,468.47
- Current membership is 445 regular members and 128 associate members
- Payouts this month: Rule quiz winner \$50, Wa Golf \$1,482, Spring field day (green fees) -\$7,050, Spring field day (payouts) - \$7,638.95
- Income this month: Spring field day \$12,893, Wa Golf \$1,974, dues \$40
- Tim filed club taxes
- Dennis to create midyear budget update before July meeting to review any adjustments for 2<sup>nd</sup> half of year

## Pro Shop / course (not present)

- Golf course is in excellent shape.
- Still on winter rules but Tournament committee to review changing to summer rules for upcoming Youngquist tournament. Course is definitely dry enough, but only concern is number of divots.

### **Tournaments (Terry)**

- There are currently 121 signed up for Younquist tourney with a week to go. Number of players to be cut off at 180 due to daylight concerns.
- Had 173 players in spring field day. Had 151 sign up for the hole in one insurance.
- New info site is maplewoodmensclub.golfgenius.com. With this site should make it easier for all members to sign up for tournaments.
- Still struggling in identifying associate members from main members. Had one associate member play in tournament. Tournament committee to continue to review better options for identifying membership.
- More discussion on requirement to play in Calcutta and Club Championship. Current requirement is one stroke play event previously to event. Other options maybe to include events in last 12 months, 3 of any events, etc. Tournament committee to review.
- Still working on player of the year points compilation. Has been difficult with golf genius although getting closer to finalizing.
