Meeting was virtual and called to order at 6:01 PM. The purpose of the meeting is to discuss the current financials, pro shop, tournaments, handicaps/rules issues as well as old and new business.

Finance (Dennis):

- Current Financial balance is \$15,485.25.
- Current membership is 436 regular members and 101 associate members.
- Payouts this month: \$6.50 – service charge, \$4,886.71 – WSE costs, \$2,133.32 - green fees, \$50.54 - terry supplies, \$5,625.30 – Tombstone green fees, \$4,754.96 – Tombstone tourney payouts, \$50 – rules quiz
- Income this month: \$4,886.17 – WSE, \$2,729 – WA Golf
- Still waiting for income for Tombstone tournament
- Tim stated that he is working with the pro shop to wait a few days to charge for green fees and tourney fees until income can be transferred.

Pro Shop / course (not present)

- Driving range is open.
- Costs have increased this year.
- Home and home with Bellevue 1st weekend of May and with Riverbend last weekend of September

Tournaments (Terry)

- For Spring field day currently have 162 players signed up. Will max out at 188. Of the 162, 81 have paid for skins. 4 of the paid will play from white tees.

- Youngquist tourney sign up will open on the 25th.
- Terry will be adding a tournament of champions to the end of the year for those flight winners of majors throughout the year.
- For spring field day Ken will help after his round is done with marshaling.
- Terry has instructed the proshop to not take any scorecards. All scorecards to be giving to tournament committee in the bar.

Handicap (Zach):

- Logan Zenner won the firsts rules quiz.
- Agreed to stay on Winter rules for spring field day. Will evaluate after this for potential change to summer rules.

Old Business:

- There will be some vacancies on the board after the 2025 season. Need to discover some members that will be interested in serving.
