**Finance (Dennis):**

- Current Financial balance is \$20,304.03
- Payouts this month: service charge -\$6.50, CC green fees - \$9,009.75, CC tourney fees - \$7,152.28, CC tourney update - \$67.64, CC hole in one fees - \$148, wa golf payment - \$1,287, office supplies - \$37.44, fall field day green fees - \$6,855.15, FFD tourney fees - \$6,549, FFD hole in one - \$127, hole in one payout \$325, service fees - \$13, board outing - \$774.97

**Tournaments (Terry)**

- Fall field day had 145 players
- 1 pace of play issue at FFD
- Out of 9 events we have had 66% participation from membership
- 2 man combined we have 58 confirmed as of today
- Tournament of Champions have 45 guys eligible and 30 of those are confirmed.
- Reviewed and working on 2026 tournament schedule

**Handicap (Zach):**

- Current membership 499. Ass members 127
- There will be no associate members next year. Wa Golf has deleted this option.

**Old Business:**

- There will be some vacancies on the board after the 2025 season. Need to discover some members that will be interested in serving. Current positions to be available after the 2025 season is Vice president, Tournament Director, and one trustee. Terry is set to move in President position and Dan to move into treasurer position.
- With Tim and Dennis leaving the board there will be some time needed on financials with new board members. This is especially true with the strip electronic banking Tim takes care of currently.
- Will need someone to take over web master duties as we are getting behind posting. One member has volunteered so currently discussing options here.
- Tim still working on updating historical data base for past winners.
- Was some discussion on potentially making the tournament director a team of board members. Was also some discussion if we are going to change the tournament director, we could look at the board in general for any changes needed before updating the bylaws.
- Tim reviewed some by-law changes made to incorporate updates to our constitution. Changes were reviewed and approved.

**New Business:**

- Member appreciation Event is booked at Maplewood. Dennis to get deposit check to Riverrock. DM to get check to Ken for raffle prizes.
- Nominations for board positions is ongoing.
- Reviewing an option to replace golf genius called Livetourney.com. Terry is going to try out on the Tournament of Champions event.
